GENERAL CAVEAT

The Caveator, Chhattisgarh State Co-operative Marketing Federation Ltd. (MARKFED), through its Managing Director, having its office at 6th Floor, Tower "C", Commercial Complex, CBD, Sector-21, Block 'C', Nava Raipur Atal Nagar, Raipur, Chhattisgarh – 492002, has floated a GeM Bid/E-Tender for Hiring of Consultancy Services – Percentage Based, including Technology Consultants, Management Consultants and Functional Consultants for IT Strategy (DPR, RFP etc.), Architect – IT Infra/Platform, DPR/RFP Preparation and Bid Process Management for Food and Public Distribution, vide Bid No. GEM/2025/B/6840889 dated 30.10.2025, through the Government e-Marketplace (GeM) Portal, under the administrative control of the Food, Civil Supplies and Consumer Protection Department, Government of Chhattisgarh, for execution of consultancy services on schedule-wise basis for a contract period of one year, with bid end date 29.11.2025. A corresponding public notice dated 06.11.2025 bearing No./ Marketing/ 3903/2025 was also issued and published in the newspaper.

The Caveator apprehends that certain parties, aggrieved by the above-stated procurement processes or eligibility conditions thereof, may file Writ Petitions under Article 226 of the Constitution of India or initiate Public Interest Litigations (PILs) or any other proceedings before the Hon'ble High Court of Chhattisgarh at Bilaspur, potentially seeking stay or interim directions against these RFPs.

That the Caveator, Chhattisgarh State Co-operative Marketing Federation (MARKFED), through its Managing Director, having its office at 6th Floor, Tower "C", Commercial Complex, CBD, Sector-21, Block 'C', Nava Raipur Atal Nagar, Raipur, Chhattisgarh, has given instructions to SHRI ANIMESH TIWARI, Advocate, practicing in the High Court of Chhattisgarh, to appear and oppose on behalf of the Caveator against any interim applications or petitions by placing the material before the Hon'ble High Court on behalf of the Caveator. If any such application or petition is filed against the Caveator, an advance notice of the same may be supplied to the undersigned.
